### Warranty and Limitation of Liability:

- All Versa products are guaranteed against defects resulting from faulty workmanship or materials, for product returned within 60 days of purchase, subject to the limitations, exceptions, disclaimers and conditions stipulated hereunder or specified with respect to particular products and posted, updated or amended on the Versa website or stipulated in Versa Media.
- 2. Versa will replace, free of charge, any products which are found to be defective in workmanship or material, provided that the following conditions are met:
  - Versa is promptly notified in writing of such defect immediately upon discovery of same and the defective product is promptly returned to Versa. Claimant must provide documentary evidence of failure, as well as the failed components or representative samples of product(s) that are alleged to have failed and agree to inspection by Versa of the system in which the alleged defective product(s) was/(were) installed.
  - the products have not been altered or modified after leaving Versa's premises, have not been used in more than one installation, show no evidence of disassembly or tampering, are not and have not been subjected to abnormal operating conditions, accident, abuse, misuse, unauthorized alteration or repair and the defect is not due, without limitation, to faulty installation, misalignment of products, vibration, ordinary wear and tear, corrosion, erosion, U.V. degradation, incompatible lubricants, pastes and thread sealants, unusual pressure surges or pulsation, water hammer, temperature shocking or fouling, acts of nature such as earthquakes, fire, flood or lightning or any other event of force majeure.
  - if the product is perishable, the product has been used or installed prior to the expiry date printed on the product.
  - the products have been used in applications or under conditions that are in accordance with the technical information or **Media** available from **Versa**.
- 3. With respect to the goods not of **Versa's** own manufacture, this warranty shall apply only to the extent that **Versa** is able to enforce a claim for liability against the manufacturer thereof.
- 4. **Versa** is not responsible for any damage to any products while being crated or transported by a third party provider or to damage caused by the installation other than by a qualified technician.

# Versa disclaims any liability or responsibility:

- · for labour, materials and/or other expenses required to replace the defective product or to repair any damage resulting from the use thereof
- for the purchaser's calculations, product drawings or engineering design specifications
- regarding the accuracy of any plans, drawings or specifications furnished to the purchaser as part of the sale of any of its products
- for loss or damage resulting from failure to abide by Versa's warnings, safety instructions or other precautionary guidelines.

Any claim of liability asserted against **Versa** whether in contract or in tort (including negligence) or otherwise with respect to or arising out of the sale, delivery, installation, repair or use of any products sold to purchaser shall not exceed the purchase price of the products determined to be defective.
